# Two-step process



## STEP 1:

Pass the Lean Green/Black Belt **theoretical exam.**



## STEP 2:

Pass the Lean Green/Black Belt **practical assessment.**

# Theoretical Exams



- ❖ Candidates can self-study for the exam; or
- ❖ The exam can be taken at the end of an APMG-accredited Lean Six Sigma Green/Black Belt course.
- ❖ Exam format:
  - ❖ 60 multiple choice questions
  - ❖ Duration: 180 minutes
  - ❖ Pass mark: 38 out of 60 (63%)
  - ❖ Open book – candidates can take up to two Lean Six Sigma books into the exam (Exercise Books are not permitted)

# Practical Assessment Requirements

- ❖ Evidence that a candidate has worked on two Lean Six Sigma projects, resulting in significant savings or cost reductions.
- ❖ Practical assessment submissions must follow the DMAIC or DMADV roadmap.
- ❖ Practical assessment templates are available, for free, via the Lean Six Sigma Academy website:
  - ❖ <https://www.lssa.eu/resources/> (in the 'Publications' section)
- ❖ The practical assessment must be submitted within 3 years of passing the theoretical exam.



# Practical Assessment: what to submit

- ❖ Practical assessment template (either the LSSA version or your own in-house version\*)
- ❖ Candidate self-assessment (either the LSSA version or your own in-house version\*)
- ❖ Sign-off of the project documentation by a Champion or controller (within your organization).
- ❖ Lean Six Sigma Practical Assessment Application Form.

*\* If using your own in-house version, please ensure that the content is the same as the LSSA version*



# Practical Assessment process

1. Register via the APMG website & pay the assessment fee:  
<https://publicexambookings.apmg-international.com/>
2. Upon receipt of payment, you will receive an email notification asking you to register in the APMG Candidate Portal.
3. Complete the registration steps and upload your assessment (using the template provided or your own in-company version).
4. Your assessment will be passed to LSSA for marking and will be marked within 4 weeks of receipt by LSSA.
5. APMG will inform you via email of your result.
6. If successful, you will receive an electronic certificate and digital badge confirming your achievement.
